Commissioner Smith made a motion to approve the minutes from January 24, 2006, Special Session and January 31, 2006, Regular Session. Commissioner Music offered a second. The motion passed unanimously.

Commissioner King made a motion to approve the HCRA claim for payment. Commissioner Music offered a second. The vote passed unanimously.

Commissioner King made a motion to approve the Local Law Enforcement Block Grant with Commissioner Music offering a second. The vote passed unanimously.

Commissioner Thomas stated we would need to wait until the Florida Department of Community Affairs made their first approval of the change before construction could start.

Commissioner Thomas stated that Gerald Holley, Attorney, needed to review the Building Departments request for fee increases before a decision is made.

Commissioner Thomas asked if the part time position that Roger Williams, Building Department, was requesting for the Planning Commission could be contracted. Commissioner Stafford stated that Attorney Holley will be consulted.

Commissioner Smith made a motion for Commissioner King to be the official. Commissioner Music offered a second. Commissioner Stafford voted no, all other Commissioners voted yes.

Amy Loflin, Special Projects Manager, requested the pay off request for Hatch Mott MacDonald to be approved on completing the CR 177-A Bridge Repair and Improvement Project. Commissioner Smith made a motion to approve with Commissioner Music offering a second. The vote passed unanimously.
