AN ORDINANCE OF HOLMES COUNTY, FLORIDA, RE-APPOINTING MEMBERS OF THE HOLMES COUNTY ENTERPRISE ZONE DEVELOPMENT AGENCY; PROVIDING SEVERABILITY CLAUSE; PROVIDING FOR THE APPOINTMENT OF THE CHAIR AND VICE CHAIR AND PROVIDING FOR THE EFFECTIVE DATE.

WHEREAS, an Ordinance adopted on <u>October 09, 2001</u>, established the Holmes County Enterprise Zone Development Agency, consisting of eleven (11) members, to carry out the economic development and re-development purposes of Chapter 290, Florida Statutes; and,

WHEREAS, an Ordinance adopted on <u>October 09, 2001</u>, established the Holmes County Enterprise Zone Development Agency, and required that the County Board of Commissioners shall, by Ordinance, appoint eleven (11) board members to the Agency; and,

WHEREAS, on October 25, 2005 a Resolution adopted by the Holmes County Board of County Commissioners re-designating the Enterprise Zone Development Agency was approved by the Florida Office of Tourism, Trade and Economic Development, effective January 1, 2006 until December 31, 2015; and,

WHEREAS, the Resolution adopted by the Holmes County Board of County Commissioners on October 25, 2005, provides for an Enterprise Zone Development Agency board which shall consist of a minimum of eight (8) and a maximum of thirteen (13) members, and shall be comprised of each of the following: The Holmes County Chamber of Commerce; a local financial or insurance entity; a business operating within a nominated area; residents living within the nominated area; non-profit community based organizations operating within the nominated area; the local workforce development board; the local code enforcement agency; and the local law enforcement agency; and,

WHEREAS, the Resolution adopted by the Holmes County Board of County Commissioners on <u>October 25, 2005</u>, provides for the term or office for the members of the Enterprise Zone Development Agency board as follows:

- (a) The member from a business operating within the nominated area and the nonprofit community-based organizations operating within the nominated area shall each serve terms of one (1) year.
- (b) The members from the residents residing within the nominated area, the local workforce development board and the local law enforcement agency shall serve three (3) years.
- (c) All other members shall each serve terms of four (4) years.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF HOLMES COUNTY, FLORIDA, AS FOLLOWS:

- Section 1. The <u>President of the Holmes County Chamber of Commerce</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, to fill a term of four (4) years, commencing on the effective date of the Ordinance and expiring on December 31, 2012.
- Section 2. <u>Fran Haithcoat</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, as the representative of a financial entity, to fill a term of four (4) years, commencing on the effective date of this Ordinance and expiring on December 31, 2012.
- Section. 3. <u>Sharon Curry</u> is hereby appointed as a member and Vice-chairman of the Holmes County Enterprise Zone Development Agency, as the representative of a business operating within the Enterprise Zone, to fill a term of one (1) year, commencing on the effective date of this Ordinance and expiring December 31, 2009.
- Section 4. The <u>Executive Director of the Tri-County Community Council</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, as the representative of a non-profit community based organization operating within the Enterprise Zone, to fill a term of one (1) year, commencing on the effective date of this Ordinance and expiring December 31, 2009.
- Section 5. <u>Tom Jenkins</u>, a resident of the Enterprise Zone is hereby appointed as a member and chairman of the Holmes County Enterprise Zone Development Agency to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring December 31, 2011.
- Section 6. <u>Kyle Coates</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, as the representative of the local

Workforce Development Board, to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring December 31, 2011.

- Section 7. The <u>Sheriff of Holmes County, Florida</u>, is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, as the representative of the local law enforcement agency, to fill a term of three (3) years, commencing on the effective date of this Ordinance and expiring December 31, 2011.
- Section 8. <u>Jace Albury</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency, as the representative of the local code enforcement agency, to fill a term of four (4) years commencing on the effective date of this Ordinance and expiring December 31, 2012.
- Section 9. The <u>Mayor of Bonifay</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency to fill a term of four (4) years commencing on the effective date of this Ordinance and expiring December 31, 2012.
- Section 10. The <u>President of the Esto Town Council</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency to fill a term of four (4) years commencing on the effective date of this Ordinance and expiring December 31, 2012.
- Section 11. <u>The Mayor of Ponce de Leon</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency to fill a term of four (4) years commencing on the effective date of this Ordinance and expiring December 31, 2012.
- Section 12. The <u>Chairman of the Holmes County Development Commission</u> is hereby appointed as a member of the Holmes County Enterprise Zone Development Agency to fill a term of four (4) years commencing on the effective date of this Ordinance and expiring December 31, 2012.
- Section 13. The <u>Executive director of the Holmes County Development Commission</u> is hereby appointed as the Enterprise Zone Coordinator and shall fulfill the duties particular to Florida Statute 290.0056.
- Section 14. If any provision or provisions of this Ordinance shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the
