### **ORDINANCE NO. 2007-17**

AN ORDINANCE OF HOLMES COUNTY, FLORIDA, AMENDING VOLUME III OF THE HOLMES COUNTY YEAR COMPREHENSIVE PLAN FUTURE LAND USE MAP SERIES, AS AMENDED; AMENDING CHAPTER 2, "FUTURE LAND **ELEMENT," PROVIDING FOR AN AMENDMENT TO THE YEAR 2010** FUTURE LAND USE MAP, AS AMENDED, CHANGING THE FUTURE LAND USE CATEGORY OF ONE PARCEL LOCATED ON HIGHWAY 81 FROM AGRICULTURAL TO COMMERCIAL **TOTALING 1.5 (+/-)** ACRES IN SECTION 25, TOWNSHIP 6N, RANGE 18W, PARCEL NUMBER 1925.00-000-000-002.000; PROVIDING FOR A TITLE; PROVIDING FOR SEVERABILTY; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 163, Part II, Florida Statutes, Holmes County adopted its Comprehensive Plan on August 16, 2000; and

WHEREAS, Chapter 125, Florida Statutes, empowers the Board of County Commissioners of Holmes County, Florida to prepare, amend, and enforce comprehensive plans for the development of the County; and

WHEREAS, the Holmes County Planning Commission (LPA) conducted a public hearing and forwarded a recommendation to the Board of County Commissioners, who have conducted a public hearing, reviewed, and approved the changes to the Plan and authorized the transmittal of the proposed changes to the Florida Department of Community Affairs (DCA) for adoption; and

WHEREAS, the Board of County Commissioners, Holmes County, Florida finds that the adoption of these amendments is in the best interest of the County and its citizens;

**NOW THEREFORE BE IT ORDAINED** by the Board of County Commissioners of Holmes County, Florida as follows:

## Section 1. Purpose and Intent

This Ordinance is enacted to carry out the purpose and intent of, and exercise the authority set out in, the Local Government Comprehensive Planning and Land Development Regulation Act, Sections 163.3161 through 163.3215, Florida Statutes, and Chapter 9J-5, Florida Administrative Code.

# Section 2. Title of Comprehensive Plan Amendment

This Small Scale Comprehensive Plan Amendment for Holmes County, Florida shall be entitled – "Small Scale Amendment 2007-01."

Section 3. Changes to the Holmes County Generalized Future Land Use Map

The Holmes County Year 2010 Comprehensive Plan Future Land Use Map Document, as amended; amending Chapter 2, "Future Land Use Element", Section 2.18; and all notations, references, and information shown thereon, is further amended to include the following future land use change depicted on the map and attached hereto as Exhibit "A":

One parcel located on Highway 81 from Agricultural, (Ag) to Commercial, (C) totaling 1.5 (+/-) acres and recorded as Section 25, Township 6N, Range 18W, parcel number 1925.00-000-002.000.

## Section 4. Severability

If any section, sentence, clause, or phrase of this Ordinance is declared to be invalid or unconstitutional by any Court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.

#### Section 5. Inclusion in the Code

It is the intention of the Board of County Commissioners that the provisions of this Ordinance shall be codified as required by Section 125.68, Florida Statutes (2007); and that the sections, subsections, and other provisions of this Ordinance may be renumbered or re-lettered and the word "ordinance" may be changed to "section," "article," or such other appropriate word or phrase in order to accomplish such intentions.

# Section 6. Copy on File

A certified copy of the enacting ordinance, as well as certified copies of the Holmes County Comprehensive Plan and Future Land Use Map as amended shall be filed with the Clerk of the Circuit Court of Holmes County, Florida, and copies shall be made available to the public for a reasonable publication charge.
