This Small Scale Comprehensive Plan Amendment for Holmes County, Florida shall be entitled – "Small Scale Amendment 2007-03."

Section 3. Changes to the Holmes County Generalized Future Land Use Map

The Holmes County Year 2010 Comprehensive Plan Future Land Use Map Document, as amended; amending Chapter 2, 'Future Land Use Element', Section 2.18; and all notations, references, and information shown thereon, is further amended to include the following future land use change depicted on the map and attached hereto as Exhibit "A":

A portion of a parcel located on Highway 90 from Agricultural, (Ag) to Low Density Residential, (LDR) totaling 9.96 (+/-) acres and recorded as Section 36, Township 3N, Range 18W, parent parcel number 2236.00-000-000-001.000. More particularly described as follows:
