ORDINANCE NO. 80-7

AN ORDINANCE PROHIBITING THE SALE, SERVING, AND CONSUMPTION OF ALCOHOLIC OR INTOXICATING BEVERAGES UPON ANY PREMISE HOLDING A LICENSE UNDER THE STATE BEVERAGE DEPARTMENT OF FLORIDA BETWEEN 12:00 O'CLOCK MIDNIGHT SATURDAY NIGHT AND 7:00 O'CLOCK A.M. THE FOLLOWING MONDAY MORNING, AND BETWEEN 12:00 O'CLOCK MIDNIGHT ON MONDAY THROUGH FRIDAY AND 7:00 O'CLOCK A.M. THE FOLLOWING MORNING; SAID ORDINANCE TO APPLY TO ALL AREAS OF HOLMES COUNTY, FLORIDA, OUTSIDE OF ANY MUNICIPALITY; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; ESTABLISHING AN EFFECTIVE DATE.

Section 1, Authority: This Ordinance is enacted pursuant to the authority granted County Governments by Florida Statutes 125.66(2).

Section 2, Purpose: It shall be unlawful for any person, firm, business, corporation, partnership, or any other legal entity, to sell, serve, or consume any alcoholic or intoxicating beverages upon any premise holding a license under the State Beverage Department of Florida within the unincorporated areas of Holmes County, Florida between the hours of 12:00 O'Clock Midnight Saturday Night and 7:00 O'Clock A.M. the following Monday morning.

Section 2-A: It shall also be unlawful for any person firm, business, corporation, partnership, or any other legal entity, to sell, serve, or consume any alcoholic or intoxicating beverages upon any premise holding a license under the State Beverage Department of Florida within the unincorporated areas of Holmes County, Florida, between the hours of 12:00 O'Clock Midnight on Monday throught Friday, and 7:00 O'Clock A.M. the following morning.

<u>Section 3, Penalties:</u> Any Violation of the provisions of this Ordinance shall be punishable by a fine of not more than \$500.00, a prison term of not more than 6 months, or both such fine and prison term.

<u>Section 4, Effective Date:</u> This Ordinance shall become effective immediately upon its enactment and being properly filed in the Office of the Secretary of State, and shall repeal all existing Ordinances in conflict herewith.
