The Holmes County Board of Commissioners met in a Special Session on the above date with the following members present: Commissioner Mickey Locke, Commissioner Danny Powell, Commissioner Phillip Music, Commissioner Bobby Sasnett and Commissioner Clint Erickson, Chairman of the Board.

Wesley Adams, County Coordinator, was present.

Angie Purvee, Deputy Clerk, was present and kept the minutes.

Chairman Erickson called the meeting to order at 4:11 p.m. Wesley Adams led the prayer and pledge.

The first agenda item was Agenda Additions or Deletions. The following changes were made to today's agenda:

- 5-1) Budget and LOGT Hearing Dates - addition
- 5-2) Legal Services Interviews – moved from #1 to #2

Commissioner Music offered a motion to approve the amended agenda with Commissioner Powell offering a second. The motion passed unanimously.

Commissioner Music offered a motion to schedule the Tentative Budget hearing for September 18<sup>th</sup> at 5:01 p.m. and the LOGT Special Session for September 18<sup>th</sup> at 4:00 p.m. Commissioner Locke offered a second and the motion passed unanimously.

The law firm of Roberts, Roberts and Roberts represented by attorneys Russell Roberts, John Roberts and John Young Roberts were present for the legal services interview. Each attorney presented their qualifications, experience and availability to serve as the County Attorney. Roberts, Roberts and Roberts proposed to charge the County \$3,000.00 per month for up to 25 hours of work and bill \$150.00 per hour for any additional hours worked.

The law firm of Fuqua & Milton represented by attorneys Clay Milton and Matt Fuqua were present for the legal services interview. Each attorney presented their qualifications, experience and availability to serve as the County Attorney. Fuqua & Milton proposed to charge the County \$3,250.00 per month for up to 22 hours of work and bill \$150.00 per hour for any additional hours worked.


